- Able to wear all required safety equipment including but not limited to hardhats, safety glasses, safety harness, ear plugs, dust masks, and gloves
- Lift up to 100 pounds of weight properly
- Ability to handle heights up to 460 feet
- Ability to work in inclement weather (heat, cold, rain, snow)
- Perform repetitious arm, hand, and leg motion
- Ascend and descend stairs and ladders
- Ability to do bending, kneeling, twisting, in confined spaces and awkward positions for extended periods of time
- Capable of climbing up and down, above, inside, and under equipment
- Required and predictable attendance

Knowledge, Skills and Abilities:

- Able to read, write and communicate clearly for log keeping and completing the equipment pre-check list
- Experience operating mobile equipment such as fork lift, dump truck, guzzler, sweeper, skid loader and water truck
- Experience using jackhammer up to 90 pounds
- Ability to work various shifts including overtime, call outs, weekends and holidays
- Ability to cross train

Duties and Responsibilities:

- Know and follow all company safety procedures and policies
- Safely operate mobile equipment such as fork lift, dump truck, guzzler, sweeper, skid loader and water truck
- Check condition of mobile equipment before operating, including tire inflation, brakes, oil, air pressure and add fuel as needed
- Report any malfunctions immediately to supervisor
- Complete equipment pre-check sheet for each piece of equipment prior to operation
- Perform cleanup duties such as cleaning feed chutes, transfer points, belts, pulleys, etc.
- Perform other duties as assigned
